## **Course Outline**

<u>Part I:</u> What is a probability? Discrete vs. continuous random variables. <u>Part II:</u> We will cover a number of examples of applications of the tools learned in 120A, including: experimental economics, natural experiments, and development economics. Part III: Additional topics: modern financial theory, CAPM and efficient markets.

The short paper will consist of a discussion of an academic article, 5-10 pages in length and due the last day of class (Wednesday, December  $4^{th}$ ).
