The Middle East in the New Century

Course Description

The Middle East changed as much as any region of the world in the twentieth century, and the ramifications of that change have become quite apparent in the previous two decades. This course offers an introduction to the history of the modern Middle East in the current century and focuses on issues like US foreign policy in the Middle East, regional tension, emergent political and oppositional movements, and the rise of new ideologies and non-state actors like the Islamic State. We will focus on the Arab world writ large, with an emphasis on Iraq and Syria, as well as Iran, Turkey, Afghanistan, and the Gulf. We will also consider the ideas and perspectives of regional actors, as they tend to be less accessible than the narratives more commonly represented in the United States.

The class is the final offering of the HINE sequence, but it also is suitable for students with no prior coursework on the region and its history, though some basic understanding of the region's more recent history will be useful. The only prerequisite is a willingness to critically interrogate the prejudices and stereotypes that often impede our understanding of this region and its peoples.
