Course Information

- Description: This course builds upon the materials you learned in Econ110A. I will assume that you are familiar with the models and the terminology presented in that course. Econ110B consists of three parts. In the first part, we will extend the basic IS-LM model by introducing the role of expectations and we will look at their effect on the economic activity and on economic policies. In the second part, we will consider the interaction between international trade and the domestic economy. In the third part, we will explore recent developments in the analysis and the design of monetary and fiscal policies.

Required Book and Materials:

- Olivier Blanchard, *Macroeconomics*, 5th ed. The UCSD custom edition is fine. The Student Study Guide by David Findley is strongly recommended. Textbooks are available at the Bookstore and at the library on reserve.
