#### **Course Overview:**

We will engage case studies as related to Latin American societies throughout time (1500-2000), a historically founded comparison based on the evolution of commodity chains and how they organized the international division of labor. One textbook, with additional readings for the research paper, according to students' interests. Additional readings to be discussed with instructor during office hours.

Following a weekly chronological order, students are expected to do the readings ahead of each class. A lively in class participation should follow, geared toward building up a joint and shared comparative interpretation over time and places, obtaining a more general sense of Latin American development patterns, and putting economic theory tools to its best use. Page numbers listed refer to the textbook.
