Syllabus

As the first of the finance sequence, Econ 173A covers the institutional structure and functioning of financial markets, considers investors' portfolio decisions, and establishes the basic risk-return trade-off as a market equilibrium. You will be introduced to a variety of asset classes in this course including stocks, bonds, cash instruments and derivatives (options).

EVALUATION

PROBLEM SETS

There will be **optional** weekly problem sets due on Wednesdays. There will be a (tentative) total of eight problem sets. You have the option of turning them in via Gradescope by the start of class on the due date.

MIDTERM EXAMS

FINAL EXAM

MISSED EXAMS

No make-up exams will be given in this class. You must take the final exam in order to receive a grade in this course. The final exam date is provided above so be sure to mark your calendar. If you miss a midterm exam without a university accepted excuse, you will receive a grade of zero for the exam. If you miss a midterm with a university accepted excuse, the weight of the final exam will be increased accordingly. Excuses for missed exams must be pre-approved by professor Gibson (except when this is not possible in an emergency situation). A student who misses an exam due to physical illness will be required to provide documentation from a health care professional indicating why the student was physically unable to take the exam. All documentation must be provided to professor Gibson within two working days of the student's return to campus. Failure to comply with any of the above in the specified manner will result in a grade of zero for the exam.
